**HORSE SHOW AGREEMENT:**

Every entry at a recognized competition shall constitute an agreement that the person making it, owner, trainer, manager, agent, rider, and the horse: 1) shall be subject to the constitution and the rules of the association and the local rules of the competition; 2) that every horse and rider is eligible as entered; 3) that I, the owner and/or rider, and any of my agents acknowledge that I participate voluntarily in the competition fully aware that horse sports and the competition involve inherent dangerous risk of injury or loss. and I agree that if any damages shall be occasioned or loss occur, by fire or other, to the horses exhibited, or to any vehicle or other article that I may send with such horses, that I will make no claim therefore; and further agree to hold this show, Lake Effects Horse Shows, Michigan Hunter Jumper Association (MHJA), Meadowview Farm, Inc., owners of the grounds, officials, members or employees harmless from any claim or demand of whatsoever kind or nature, that may be occasioned by the horse or horses exhibited by me, or the negligence of the persons in charge of such horses, and to repay to this show on demand, all damages it may sustain by reason of any claim or demand as aforesaid.
